Computer System - Electronic data processing and storage devices, computer processing unit (CPU); internal and peripheral storage devices such as fixed disks, external hard disks, floppy disk drives, diskettes, tape drives and tapes, optical storage devices or other memory storage devices, cell phones; peripheral input/output devices such as keyboards, printers, video display monitors, optical readers and related communications devices such as modems; together with the system ownership documentation, operating logs, software and instruction manuals, and any purchases of memberships to child pornography related websites.

You are further commanded to seize said property, persons, and/or objects if they be found and to produce before

the Virginia Beach Circuit Court an inventory of all property, persons, and/or objects seized.
